The Office of Fair Trading's Consumer Codes Approval Scheme (CCAS) aims to approve and promote business-to-consumer codes of practice which provide benefits to consumers that go beyond those provided by law. Codes that have been approved under CCAS have met strict criteria laid down by the OFT and have earned the right to display the OFT's Approved code logo. Where a business displays this logo, consumers can have the confidence of knowing that they will be dealing with a trader that has undertaken to treat them fairly if problems arise, and deliver customer service standards that go beyond minimum legal requirements.

Dealing with a complaint?

- In those sectors covered by a code, **consumers should check to see whether the trader is a member of a scheme.**
- Under the CCAS, code members are required to have in place a speedy, responsive, accessible user-friendly procedure for dealing with complaints. **Consumers should therefore use these procedures in order to resolve their dispute.**

- All approved codes have a three stage process for handling complaints:
 - The complaint should first of all be made by the consumer to the trader (the member).
 - If the trader and the complainant cannot come to an agreement, then the opportunity should then be given for the complaint to be resolved through mediation/conciliation. This is usually provided by the code sponsor.
 - If this fails then the consumer should be given access to the independent redress scheme. Details on the three stage complaints handling process can be found in OFT's booklet 'Making a complaint under the OFT Consumer Codes Approval Scheme', which is available from the OFT by calling 0800 389 3158 and can be downloaded from its codes website.
